3 - MODIFICATIONS

The present EC Type Examination Certificate has been issued as a consequence of the following modifications:

- Addition of models of air cylinders (2 liters 300 bar), of steel and composite material (only for the model SK 1203); the marking informations have been modified as a consequence (has been added a new model "SK 1203 C" for the use with air cylinder in composite material).
- Modification of the design of the activation lever
- Revision of the instructions for use (code 900170000 rev.4)

The PPE models SK 1203 and SK 1302 have been already EC certified with EC Type Examination Certificate n° PPE/AT 877-09 Prot. 1513/09 issued by Italcert on 2009-12-22, which is nullified and substituted by the present.

4 - EVALUATION AND ASSESSMENT

Such classification correspond within the italian legislation to the Category III.
